Who owns Wellington Battery energy storage system?

AMPYR Australia has acquired Shell Energy Australia's 50 per cent stake in the 300 MW /600 MWh Wellington battery energy storage system (BESS) stage one project in New South Wales. AMPYR already owns Wellington BESS stage two (100 MW /400 MWh), so now owns 100 per cent of the total 1,000 MWh project.

What makes our Wellington storage facility special?

Our Wellington storage facility is extra special as it has multiple access points to the storage units and undercover loading areas to protect you from the Wellington weather.

Who is delivering the Wellington Stage 1 Bess project?

The project will be delivered by United States-based Fluence Energy, using its Gridstack energy storage product. Fluence has also entered into a 20-year operational service contract to service and maintain the Wellington Stage 1 BESS, with revenues to be optimised by the company's Mosaic and Nispera software platforms.

Does amp yr own the Wellington Bess project?

Amp yr now owns 100% of the 400MW Wellington BESS project in New South Wales. Amp yr Australia has acquired Shell's 50% stake in the 300MW Wellington battery energy storage system (BESS) in New South Wales. With its Wellington BESS stage two project (100MW), Amp yr now owns 100% of the 1000MWh Wellington project.

The project will include the full suite of Fluence's innovative storage products, including Gridstack(TM).

AMPYR is on track to deliver 6,000 MWh of grid-scale battery storage in strategic grid locations by 2030, providing up to 20% of Australia's future battery storage demand.

The Wellington Stage 1 BESS is AMPYR's first grid-scale battery energy storage system to reach financial close in Australia. This project is scheduled to be energised in 2026, ...
